b. **NOTE 2**: Due to limited care facilities the Navy and most other branches of service requires Overseas screening prior to transferring to Key West. Nearest major care facilities are located in Miami 4 hours away. (CH)

c. **NOTE 3**: Military and Civilian housing is far smaller than on the mainland, between 900-1300 square feet. It is highly recommended that member contact housing/sponsor or place large or excess goods in NTS at origin. Local NTS is limited and not climate controlled. (CH)

d. **NOTE 4**: Due to very high cost of living, military and low ranking civilians cannot afford Key West rents; small 1 bedroom apartments start at \$1300.00. (CH)

e. **NOTE 5**: Unaccompanied military are assigned to aboard ship, barracks or shared housing. Housing is completely furnished and Government furnishings will not be removed from housing. Highly recommend placing HHG in NTS at origin. (CH)
