b. **TGBL HHG, TGBL BAGGAGE:** Consign to member or member's agent at delivery address if known; otherwise, consign to member at destination city/installation where member will reside/is assigned. Annotate PPGBL: "Carrier will notify JPPSO-WA, Ft Belvoir, VA, at (703) 806-4900 or 1-800-762-7186 prior to delivery or placing in storage."

c. **PARCEL POST:** Do not consign parcel post shipments to JPPSO-WA. Marine Corps personnel assigned to MCDEC, Quantico, consign to TMO MCDEC, Quantico, VA 22134. For all other Marine Corps personnel assigned to the Washington DC area, consign to member c/o unit of assignment.

d. **FIREARMS:** Do not mail firearms to JPPSO-WA by parcel post. Firearms should be mailed to members address or shipped in personal property.

e. **MOBILE HOMES:** Storage space is extremely limited. TOs are requested to telephone the Clearing Branch to determine if storage space is available.

3. **SPECIAL INSTRUCTIONS:**

a. **NOTE 1:** Activities serviced by JPPSO-WA are:

(1) **District of Columbia:** Bolling AFB, Ft McNair, Naval Research Lab Wash, Navy Yard Wash, Naval Station Anacostia, Walter Reed Army Medical Center, and US Coast Guard Wash.

(2) **Maryland:** Andrews AFB (Prince Georges), Bethesda Naval Hospital (Montgomery) (see Note 7), Cheltenham Navy Annex (Prince Georges), Ft Meade (Anne Arundel), and Naval Ord Station Indian Head (Charles) (see Note 6).

(3) **Virginia:** Ft Belvoir (Fairfax), Ft Myer (Arlington), Henderson Hall (Arlington), MCCDC Quantico (Prince William), Naval Surface Weapons Ctr, Dahlgren Lab (King George), Pentagon (Arlington), and Vint Hill Farms Station (Fauquier).

(4) **West Virginia:** Naval Radio Station Sugar Grove (Pendleton).

b. **NOTE 2:** June through September deliveries from storage-in-transit (SIT) are very difficult to arrange in a timely manner due to agent saturation and heavy peak workload. Deliveries can take up to 15 to 20 days notice to the agent. For direct deliveries advise the member to contact this office to furnish contact information.

c. **NOTE 3:** Independent city of Richmond, VA, is geographically located in Henrico County and not in Richmond County. The responsible PPSO for the city of Richmond is Ft Lee, VA.

d. **NOTE 4:** Sugar Grove, WV, has been designated a remote area. Members assigned to Sugar Grove are entitled to nontemporary storage.

e. **NOTE 5:** Do not consign shipments to this area for permanent storage (NTS). Consign to the property water port (Bayonne NJ or Oakland Army Terminal) "Hold for member". NTS as an alternative to shipment should be considered for those members attending long term schools and have no intention of taking delivery of their property. Storage (SIT) extensions require strong justification for approval.

f. **NOTE 6:** Personnel assigned to the EOD School at Indian Head, MD, and plan to reside in Government quarters should place their household goods in nontemporary storage at origin. These quarters are fully furnished. The only items that should be shipped are TV, stereos, VCRs, linens, dishes, pots and pans, etc.

g. **NOTE 7:** Single personnel assigned PCS to schools at NMMC, Bethesda, MD, are encouraged to contact the school prior to shipping household goods. There may be a requirement for single enlisted personnel to reside in the barracks. Large items of furniture cannot be utilized in the barracks and should be stored at origin.

h. **NOTE 8:** Misconsigned shipments are resulting due to confusion between Langley, VA, and Langley AFB, VA. Langley, VA, (Arlington County) is the responsibility of 47-3, JPPSO-WA while Langley AFB, Hampton (IC), VA, is the responsibility of 47-4, CPPSO Langley AFB.
