SUBJECT: CARRIER PERFORMANCE ACTION – MERIDIAN MOVING & STORAGE,
INCORPORATED (MRDG)

1. EFFECTIVE IMMEDIATELY, MERIDIAN MOVING & STORAGE, INCORPORATED
(MRDG), IS PLACED IN WORLDWIDE NONUSE FOR ALL DEPARTMENT OF DEFENSE
DOMESTIC AND INTERNATIONAL CODES OF SERVICE, INTO AND OUT OF ALL
RATE AREAS UNTIL FURTHER NOTICE FROM SDDC. THIS ACTION IS BEING

TAKEN BECAUSE MRDG HAS NOTIFIED SDDC THAT THEY ARE HAVE FINANCIAL PROBLEMS.

2. ALL ITOS WILL FOLLOW PROCEDURES OUTLINED IN CHAPTER 410.F.2 OF THE DEFENSE TRANSPORTATION REGULATION (DTR) PART IV, PAGE IV-410-11.

3. NO NEW TONNAGE WILL BE OFFERED TO MRDG.

4. ITOS WILL PROVIDE SDDC (CONUS) , SDDC EUROPE, AND SDDC PACIFIC (OCONUS), A LIST OF ANY SHIPMENTS THAT HAVE NOT ARRIVED AT DESTINATION BY THE RDD WITHIN THREE (3) WORKING DAYS FROM THE DATE OF THIS MSG IS RECEIVED.

5. SHIPMENT ALREADY BOOKED WITH THE CARRIER AND STILL AT ORIGIN OR SHIPMENTS THAT ARE BOOKED AND HAVE NOT BEEN PICKED UP MUST BE PULLED BACK AND RETENDERED TO OTHER CARRIERS WITH THE SAME AGENT IF POSSIBLE.

6 SHIPMENTS IN THE PIPELINE (I.E., SHIPMENTS THAT HAVE MOVED BEYOND THE ORIGIN AGENTS WAREHOUSE) WILL BE THE CARRIERS RESPONSIBILITY TO COMPLETE MOVEMENT. SHIPMENTS BEING PLACED IN STORAGE-IN-TRANSIT (SIT) OR ALREADY IN SIT WILL BE TERMINATED EFFECTIVE THE DATE THEY ARE PLACED IN SIT.

7. THE DECISION AND SUPPORTING INFORMATION REGARDING THE CARRIER ABOVE WILL BE FORWARDED TO THE APPROPRIATE REGIONAL STORAGE MANAGEMENT OFFICE CONTRACTING OFFICER FOR POSSIBLE ACTION TO TERMINATE THE CARRIER/AGENT NONTEMPORARY STORAGE BASIC ORDERING AGREEMENT.

8. IAW THE ABOVE MENTIONED DTR REFERENCE ITOS ARE ASKED TO KEEP COPIES OF THE ORIGINAL GBLs, RETENDERED GBL CORRECTION NOTICE'S, PURCHASE ORDERS OR FREIGHT WARRANT, AND COPIES OF THE ORIGINAL AND RETENDERED GBLs TO SDDC ATTN: SDPP-PO, DSN: 328-3018, COML: (703) 428-3218, ONCE THE SHIPMENTS HAVE ARRIVED AT DESTINATION.

9. SHIPMENTS THAT BECOME FRUSTRATED MUST BE REPORTED TO SDDC (CONUS), SDDC, EUROPE OR SDDC PACIFIC (OCONUS) FOR ADDITIONAL GUIDANCE AND INSTRUCTIONS.
