SUBJECT: SHIPMENTS HELD HOSTAGE

A. REFERENCE HQ MTMC MESSAGE 051236Z OCT 01, SAB

1. WE RECEIVED NOTICE OF AGENTS HOLDING SHIPMENTS HOSTAGE BECAUSE OF NONPAYMENT FOR SERVICE PERFORMED ON BEHALF OF THE CARRIER.

2. AS A PARTICIPATING CARRIER IN THE DEPARTMENT OF DEFENSE (DOD), PERSONAL PROPERTY PROGRAM, CARRIERS ARE REQUIRED TO PROVIDE RESPONSIBLE, RELIABLE, TRANSPORTATION OF SHIPMENTS TENDERED TO THEM UNDER GOVERNMENT BILL OF LANDING (GBL). TIMELY PAYMENT FOR AGENT AND SUBCONTRACTOR SERVICES IS A CRITICAL ELEMENT OF THE CARRIER RESPONSIBILITIES.

3. IN A LETTER TO INDUSTRY DATED 2 OCT 00, MTMC REQUESTED CARRIERS TO ACKNOWLEDGE THAT THEY, THEIR AGENTS AND SUBCONTRACTORS AGREE TO ABIDE BY U.S. LAW (37 U.S.C. 406 (L) PROHIBITING ASSERTION LINES AGAINST DOD-SPONSORED HOUSEHOLD GOODS SHIPMENTS. IT IS OUR INTENT TO TAKE CARRIER REVIEW BOARD ACTION ON ALL CASES OF SHIPMENTS BEING HELD HOSTAGE.

4. ALL INSTALLATION TRANSPORTATION OFFICES (ITOS) ARE ASKED TO PROVIDE THE FOLLOWING TO THIS HQ WHEN A SHIPMENT IS HELD HOSTAGE IN YOUR AREA OF RESPONSIBILITY:

- A. NAME AND SCAC CODE OF CARRIER.
- B. MEMBERS NAME, GBL NUMBER, PICKUP DATE, RDD, ORIGIN AND DESTINATION ITOS.
- C. NAME OF AGENT, STREET ADDRESS, CITY, ZIP CODE, AND TELEPHONE NUMBER.
- D. ANY WRITTEN DOCUMENTATION FROM THE AGENT RELATED TO THE SHIPMENT HELD HOSTAGE.
